4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. The International Agency for Research on Cancer (IARC) have classified respirable crystalline silica as a Group 1 human carcinogen. Lung cancer risk has been directly associated with the development of silicosis. Work practices preventing the development of silicosis will prevent lung cancer risk.
